ORDINANCE NO. 1127

**AN ORDINANCE OF THE TOWN OF FREDERICK, COLORADO, AMENDING
ARTICLE VIII OF THE *FREDERICK MUNICIPAL CODE* FREDERICK HIGH
SCHOOL SCHOLARSHIP PROGRAM**

WHEREAS the Board of Trustees has determined that the scholarship program should be expanded to include any resident of the Town of Frederick that graduates from an accredited high school or accredited home school program in Colorado.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF FREDERICK, COLORADO, AS FOLLOWS:

Section 1. Article VIII of the Frederick Municipal is amended in its entirety and replaced with a new Article VIII attached hereto entitled "**Frederick Scholarship Program.**"

Section 2. Effective Date. This ordinance shall be published and become effective as provided by law.

Section 3. Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of the ordinance. The Town Board hereby declares that it would have passed the ordinance including each part, section, subsection, sentence, clause or phrase thereof, irrespective of the fact that one or more parts, sections, subsections, sentence, clauses or phrases are declared invalid.

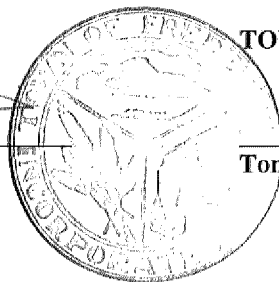
Section 4. Repealer. All ordinances or resolutions and motions of the Board of Trustees of the Town of Frederick or parts thereof, in conflict with this ordinance are to the extent of such conflict hereby superseded and repealed, provided that such repealer shall not repeal the repealer clauses of such ordinance, resolution or motion, nor revive any ordinance, resolution or motion thereby.



Frederick Scholarship Program

Sec. 4-161. Authority.

The Board of Trustees hereby establishes a scholarship program for residents of Frederick who have graduated from an accredited high school or accredited home school program in Colorado.

The Board of Trustees shall award one (1) scholarship to a graduating male and one (1) scholarship to a graduating female. Each scholarship shall be payable at one thousand dollars (\$1,000.00) per year for the first four (4) years of college eligibility not to exceed six (6) years after the initial award provided that the recipient maintains his or her eligibility. (Ord. 949 §1, 2008)

Sec. 4-162. Scholarship Commission.

A Scholarship Commission is established to act in an advisory capacity to the Board of Trustees and make recommendations in accordance with the provisions of this Article. The Scholarship Commission shall consist of the Mayor, the assistant superintendent for the Frederick feeder system, one (1) local business or community leader and one (1) citizen of the Town. The membership of the Commission shall be designated by the Mayor and approved by the Board of Trustees. (Ord. 949 §1, 2008; Ord. 1088 §1, 2012)

Sec. 4-163. Terms of office.

(a) The Mayor and the assistant superintendent shall serve terms corresponding to their terms in office and in their positions.

(b) The resident members of the Commission shall serve terms of four (4) years. (Ord. 949 §1, 2008; Ord. 1088 §1, 2012)

Sec. 4-164. Rules of order and business.

The Scholarship Commission shall adopt rules and regulations governing the conduct of its meetings. A majority of its membership shall be required to conduct official business. All members have equal voting privileges on all questions. All members shall comply with the provisions regarding ethics and conflicts of interest contained in Chapter 2, Article IV of this Code. (Ord. 949 §1, 2008) In the event that a child of one of the members is a scholarship applicant, that member shall be replaced by a person holding a similar position within the community.

Sec. 4-165. Qualifications.

To be eligible for consideration, the candidate must meet the following requirements

(2) Must be a resident of the Town.

(3) Must have a cumulative grade point average of 3.0 and must have taken a college preparatory curriculum.

(4) Must have excelled in extra-curricular activities such as drama, music, art, student government, athletics, science clubs, etc. (Ord. 949 §1, 2008)

Sec. 4-166. Restrictions.

(a) The student must attend an accredited college or university and have a plan to pursue a bachelor's degree. Attending a junior college for the first two (2) years is acceptable.

(b) To remain eligible for funding, the student must achieve at least a 3.0 grade point average for each year.

(c) The Scholarship Commission will review all continuing students (students awarded the scholarship in previous years) for compliance with grade point average requirements and recommend to the Board of Trustees continuation or termination of the scholarship. (Ord. 949 §1, 2008)

Sec. 4-167. Application and selection.

(a) Application for the scholarship is to be made on the form supplied by the Town.

(b) Selection will be based on recommendations by staff and teachers and review of the scholarship application by the Scholarship Commission.

(c) The Scholarship Commission will make a recommendation of one (1) male and one (1) female recipient each year to the Board of Trustees. (Ord. 949 §1, 2008)

Sec. 4-168. Payment of funds.

Payment of the scholarship will be made directly to the school, college or university annually. (Ord. 949 §1, 2008)

Sec. 4-169. Source of funds.

The scholarship program shall be funded from interest earned annually from the Oil Royalty Trust Fund.
