TOWN OF FREDERICK, COLORADO ORDINANCE NO. 1132 AN ORDINANCE OF THE TOWN OF FREDERICK, COLORADO, AMENDING SECTION 13-137 OF THE *FREDERICK MUNICIPAL CODE* CONCERNING ELECTRICAL RATES FOR LARGE INDUSTRIAL CUSTOMERS.

WHEREAS, it is the intention of the Board of Trustees to establish electrical rates for its customers which are fair, equitable, and sufficient to support the expenses of the Electrical Works of the Town of Frederick; and

WHEREAS, the Board of Trustees finds it necessary to adopt a transition rate to reflect service to large industrial customers of a type not previously served by the Town of Frederick and remain competitive with other electrical service providers within the service area of the Electrical Works, with said new rates to become effective on May 1, 2013; and

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF FREDERICK, COLORADO, AS FOLLOWS:

Section 1. Section 13-137 of the *Frederick Municipal Code* is amended by adding subparagraph (6) to Section 13-137.a. - Electrical Service Charges, to read as follows:

"Section 13-137.a.(6)"

(6) Transition Large Industrial.

Service Charge	\$75.00
Energy Charge	\$ 0.07580/kWh
Demand	\$5.75

- (a) Application. This rate applies to all lighting and power service loads for large industrial uses requiring single-phase or three-phase service exceeding 100 kilowatts.
- (b) Type of Service. Single-phase or three-phase 60 cycle, at primary voltage, exceeding 100 kilowatts.
- (c) Service Charge. Base charge for availability of electric service and system overhead.
- (d) Energy Charge. Base charge for energy used, charged for all kilowatt-hours used.
- (e) Demand. Base charge for Demand is \$5.75 per kilowatt, but not to exceed \$0.23 per kilowatt-hour used.
- (f) Billing Demand Charges. The billing of demand charges are determined by metered measurement of the maximum 15 minutes integrated kilowatt demand used during the month.
- (g) Power Factor Adjustment. The customer shall maintain unity power factor as nearly as practicable. If the power factor for the period during which the billing demand is established is below 95 percent lagging, then the demand as measured shall be adjusted by increasing the measured demand one percent (1.0%) for each percent (1.0%) that the power factor is below 95 percent lagging.
- (h) Payable. All bills shall be paid by the due date on the bill.
- (i) Minimum Service Period. The minimum service period for a large industrial

customer is one year. Thereafter, service may be discontinued upon giving three days' written notice to the Town. The consumer shall be responsible for the payment of all charges through the date of discontinuance.

Section 2. Effective date. This ordinance shall be published and become effective as provided by law.

Section 3. Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is held to be invalid for any reason, such invalidity shall not affect the validity of the remaining sections of the ordinance. The Town Board hereby declares that it would have passed the ordinance including each part, section, subsection, sentence, clause or phrase thereof, irrespective of the fact that one or more parts, sections, subsections, sentence, clauses or phrases be declared invalid.

Section 4. Repealer. All ordinances or resolutions and motions of the Board of Trustees of the Town of Frederick or parts thereof in conflict with this ordinance are to the extent of such conflict hereby superseded and repealed, provided that such repealer shall not repeal the repealer clauses of such ordinance, resolution or motion, nor revive any ordinance, resolution or motion thereby.
