## TOWN OF FREDERICK, COLORADO ORDINANCE NO. <u>1205</u>

## AN ORDINANCE OF THE TOWN OF FREDERICK, COLORADO, AMENDING CHAPTER 6, ARTICLE III, SECTION 6-72 AND ADDING SECTION 6-78 OF THE *FREDERICK MUNICIPAL CODE* WITH RESPECT TO LIQUOR LICENSING

WHEREAS, THE Board of Trustees has determined that it is in the best interests of the community to amend its liquor licensing code to include a requirement for responsible vendor training and for administrative approval of special events permits.

# BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF FREDERICK, COLORADO, AS FOLLOWS:

**Section 1.** Chapter 6, Article III, Section 6-72 of the *Frederick Municipal Code* is hereby repealed in its entirety and reenacted to read as follows:

#### "6-72 Receipt of application for new license or renewal of existing license.

(a) The Town Clerk shall review any application for a new license or renewal, including all supporting documents, and advise the applicant of any additional information and/or documents that are needed to complete the application or renewal. The date on which the completed application and all necessary documents are filed with the Town Clerk and all necessary application fees are paid in full shall be deemed the date of filing of the application for the purposes set forth in Title 12, Articles 46, 47 and 48, C.R.S. (Ord. 736 §1, 2004)

(b) The applicant for a new license or renewal of an existing license shall certify that all servers or sellers of alcoholic beverages have complied with responsible vendor training programs within 90 days of hire and have current certificates of completion. (CRS §12-47-11002)"

Section 2. Chapter 6, Article III, Section 6-78 of the *Frederick Municipal Code* is hereby added to read as follows:

#### **"6-78 Approval of Special Events Permits**

(a) Applications for Special Events Permits are deemed to be routine in nature and may be approved by the Town Clerk or Town Manager subject to all posting requirements by the state licensing authority. Additional local requirements may be enacted by resolution. (CRS §12-48-107)

(b) Pursuant to CRS § 12-48-107(5) the Town specifically opts out from requiring the state licensing authority's approval or disapproval of an application for a special event permit.

Section 3. Effective Date. This ordinance shall be published and become effective as provided by law.

Section 3. Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of the ordinance. The Town Board hereby declares that it would have passed the ordinance including each part, section, subsection, sentence, clause or phrase thereof, irrespective of the fact that one or more parts, sections, subsections, sentence, clauses or phrases are declared invalid.

Section 4. Repealer. All ordinances or resolutions and motions of the Board of Trustees of the Town of Frederick or parts thereof, in conflict with this ordinance are to the extent of such conflict hereby superseded and repealed, provided that such repealer shall not repeal the repealer clauses of such ordinance, resolution or motion, nor revive any ordinance, resolution or motion thereby.
