RESOLUTION NO. 17-R-16

A RESOLUTION OF THE TOWN OF FREDERICK, COLORADO,
REGARDING THE PROVISION OF EMERGENCY SERVICES TO AN
ANNEXATION OF THE TOWN OF FREDERICK

WHEREAS, by Ordinance number 1237, the Town of Frederick (“Town”) annexed property known as the PDK Annexation within its corporate boundaries. The PDK Annexation was recorded on December 9, 2016, and became effective as of that date. A copy of the legal description for the PDK Annexation is attached as Exhibit A;

WHEREAS, the Town and the Frederick-Firestone Fire Protection District (“Frederick-Firestone FPD”) entered into an intergovernmental agreement (“IGA”) on September 25, 2003, which obligates Frederick-Firestone FPD to provide, and designates Frederick-Firestone FPD as the sole provider of, fire prevention, fire suppression, emergency medical, emergency rescue, ambulance, and hazardous materials services (collectively, “Emergency Services”) to all property within the Town’s corporate boundaries. On June 26, 2012, the Town renewed the IGA for a ten-year term to expire September 25, 2023;

WHEREAS, the PDK Annexation is currently located within the boundaries of the Mountain View Fire Protection District (“Mountain View FPD”), which currently provides the Emergency Services to the PDK Annexation;

WHEREAS, the Town, through the IGA with Frederick-Firestone FPD, can provide the same or better fire protection and Emergency Services to the PDK Annexation as Mountain View FPD currently provides; and

WHEREAS, the Town Board of Trustees believes it is in the best interests of the PDK Annexation and the Town, and the Town’s citizens and their property, for the Town, through the IGA with Frederick-Firestone FPD, to provide the Emergency Services to the PDK Annexation immediately upon exclusion of the PDK Annexation from Mountain View FPD.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF FREDERICK, WELD COUNTY, COLORADO, THAT:

Section 1. The Town, through the IGA with Frederick-Firestone FPD, will provide the Emergency Services to the PDK Annexation on and after the effective date of the Court Order excluding the PDK Annexation from Mountain View FPD.

Section 2. The Board of Trustees authorizes Town staff to take all actions necessary to exclude the PDK Annexation from Mountain View FPD pursuant to C.R.S. §32-1-502 as may be amended from time to time.

Section 3. The Board of Trustees also ratifies any action previously or currently undertaken by Town staff to exclude the PDK Annexation from Mountain View FPD.

Section 4. **Effective Date.** This resolution shall become effective immediately upon adoption.

Section 5. **Repealer.** All resolutions or parts thereof, in conflict with this resolution are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such resolution nor revive any resolution thereby.

Section 6. **Certification.** The Town clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.


